#### **ELECTRONIC MATERIALS INSTRUCTIONS**

It can sometimes be difficult to determine how to count electronic materials for the Public Libraries Survey. Please refer to this document for tips on common electronic material platforms. In most cases, if the e-material has a circulation period, it should be counted in circulation. If it does not have a circulation period, it should be counted in database retrieval. For pay-per-use models, only report the number of titles that were actually used and therefore paid for.
