Total Doses Administered: Total COVID-19 vaccinations administered in the State of Montana. This includes first and second doses.

<u>Total Montanans Fully Immunized</u>: Total people in Montana that have been fully immunized with the number of doses specific to vaccine manufacturer and ACIP recommendations.

<u>Percent Montanans Fully Immunized</u>: Percent of the eligible population in Montana who have been fully immunized with the number of doses specific to vaccine manufacturer and ACIP recommendations.

<u>COVID-19 Vaccinations by County</u> (List of All Counties): Lists all Counties in Montana with details showing the number of fully immunized persons and the total doses administered within each County. Data is sorted by County Name. These County details will be updated once a week (Fridays).

<u>Map</u> – Interactive thematic map of Montana displaying the percent vaccinated by County. The darker the color, the higher percentage of vaccinations administered to the eligible population. Calculations are made using 2020 population data.

- Home button: Select to return to the full extent of the state of Montana.
- <u>Legend</u>: Select to view the map legend.
- <u>Identify</u>: Tap/Click on a county to open a pop-up to identify the county name and details for the selected county.
- <u>Zoom In/Out:</u> Plus button zooms in and minus button zooms out.
- Map Data Pop-Up
 - Population Eligible to be Vaccinated: *Individuals 12 years of age and older (see population data source on the next page).
 - Dose #1 Administered: Number of first doses of COVID-19 (for vaccines that are part of a two dose series).
 - Total Doses Administered Number of COVID-19 vaccine doses administered. This includes Dose 1 and Dose 2
 - Number Fully Immunized Number of individuals who have completed the series (one or two doses specific to vaccines manufacturer and ACIP recommendations).
 - Fully Vaccinated per 100,000 Rate of eligible population per 100,000 individuals who are fully vaccinated.
 - Percentage of Eligible Population Fully Vaccinated: Percent of eligible individuals who have completed the series (one or two doses specific to vaccines manufacturer and ACIP recommendations).
